PROTECTION OF PUBLIC HEALTH ORDINANCE, 1999

PROTECTION OF PUBLIC HEALTH (MEASURES ON THE CARRYING OUT OF
ACTIVITIES AND MOVEMENT OF PERSONS WITHIN INFECTED LOCAL AREAS) (No. 2)
ORDER, 2020

(Made under section 15)

In exercise of the powers conferred by section 15 of the Protection of Public Health Ordinance, 1999 [*Cap. 30*], the Minister has made the following Order:

Citation and Commencement

1.—(1) This Order may be cited as the **Protection of Public Health (Measures On The Carrying Out of Activities and Movement of Persons Within Infected Local Areas)(No. 2) Order, 2020**.

(2) This Order shall come into force from 1st day of September, 2020 until 31st day of December, 2020, and shall be read together with the Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (No. 8) Regulations 2020 [*P.U. (A) 254/2020*].

Interpretation

2. In this Order—

“infected local area” means any area declared to be an infected local area under the Prevention and Control of Infectious Diseases (Declaration of Infected Local Areas) Order 2020 [*P.U. (A) 87/2020*] read together with the Prevention and Control of Infectious Diseases (Declaration of Infected Local Areas)(Extension of Operation) (No. 6) Order 2020 [*P.U. (A) 253/2020*]; and

“Regulations” means the Prevention and Control of Infectious Diseases (Measures within Infected Local Areas) (No. 8) Regulations 2020 [*P.U. (A) 254/2020*].

Measures for monitoring movement, etc.

3.—(1) Any person may be required to comply with any measure determined by the Minister for the purposes of monitoring his movement within the State.

(2) The measures in paragraph (1) above may include the use of electronic tagging or any other means as issued by the Sarawak Disaster Management Committee with the approval of the Minister.

Measures for carrying out of activities

4. Any person carrying out or intending to carry out any activity not prohibited under the Regulations shall comply with any guidelines or standard operating procedures issued from time to time by the State Disaster Management Committee with the approval of the Minister.

Director may issue directions, etc.

5. The Director may from time to time, with the approval of the Minister issue any direction in any manner, whether generally or specifically to any person or group of persons, necessary for carrying out the provisions of this Order.

Offence

6. Any person who contravenes any provision of this Order or any direction made hereunder commits an offence.
